<u>Call to Order</u>: Meeting was called to order by David Driver at 7:15 p.m.

<u>Verify Quorum</u>: a quorum was achieved with eleven (11) lots represented in person and five (5) lots represented by proxy for a total of 16 lots.

Architectural Review Committee in process of gathering and compiling exterior paint colors – ARC looking for volunteers to join.

## New Business:

- Community Update: Front gate pavers saving money in water since sprinkler system removed where pavers installed.
- 2009 Budget/Assessment Reserve Study conducted revealed not enough in reserves at this time. David Driver referred to Moss Creek Reserve Funding Overview one sheet and discussed amount recommended to be put in reserves for
